PRIVACY STATEMENT

When you visit our website, <u>www.niezinkfinance.com</u>, or contact us, we receive information about you. In this privacy statement, we explain how we handle that information. We always treat your information with care and store it securely. If you have any questions or wish to know what information we hold about you, please contact us. We may update our privacy statement when necessary, so we recommend that you review it regularly to stay informed of any changes. This privacy statement was last updated on July 28, 2023.

1. When does this privacy statement apply?

This privacy statement applies to all personal data we process and all domains related to us. It concerns the personal data of anyone who has had contact with us or visited our website, including visitors, customers, and business contacts. Personal data refers to any information traceable to you as an individual, such as your (company) name, place of residence, phone number, and email address. For more information on personal data, we refer you to the website of the Dutch Data Protection Authority.

2.Who is responsible for my data?

Niezink Finance is responsible for the website <u>www.niezinkfinance.com</u> and is therefore the organization responsible for the use of your personal data as described in this privacy statement.

3.Whose data do we process?

We process the personal data of anyone who has contacted us or visited our website. This includes business relations.

4. How do we collect your data?

We collect your data directly from you when you fill in your details on our website.

5.What data do we use?

We use the following data: company name, address, email address, phone number, date of birth, and information regarding your use of our services.

6.Why do we use your data?

We only use your personal data for the purposes you have consented to: we have your permission to use your personal data, or we use your data because we want to provide you, as a customer, with the best possible service, which would be impossible without that information.

7. How long do we retain your data?

We retain your personal data for as long as required by law and for as long as necessary to fulfill the purpose for which we are using your data. For example, as long as you are our customer, we retain your data according to the statutory retention period of seven years. After that, we will only retain your data for statistical purposes or to handle any complaints or legal matters. 8.With whom do we share your data?

Your personal data is used solely by us. We will never share your personal data with others.

9. How secure is your data with us?

We have taken extensive organizational and technical measures to protect your data. Our systems and various communication channels are secured to prevent your data from falling into the wrong hands. Your data is safe with us. We also ensure that your data is only accessed by those who are authorized by us. 10.What are your rights?

Since we process your personal data, you have several rights, which we list below for your convenience.

• Right to information

We will explain clearly and transparently how we handle your data and what control you have over it. This privacy statement provides detailed information on what data we collect from you and how we manage it.

Right of access

You have the right to request access to the personal data we hold about you.

• Right to rectification

You may request the correction of your data if it is incorrect or incomplete.

• Right to object

You may object to the processing of your data if you disagree with how we are handling your personal data. This right applies to data used for direct marketing, for instance, allowing you to indicate that you no longer wish to receive emails from us.

• Right to data portability

If you are a customer or have given consent for the use of your data, you can request that we send you the digital data we hold about you so that you can transfer it to another organization.

Right to restriction

You may request us to limit the use of your data, meaning we may only store your data but not use it in certain circumstances.

• Right to be forgotten

You may request that we delete all data we hold about you. We will then delete all data traceable to you. In some cases, we may be unable or not allowed to delete your data, for example, when we are required to retain some data for seven years for tax purposes.

11.What rules apply to this privacy statement?

Our privacy statement must comply with various regulations, mainly the General Data Protection Regulation (GDPR). Additionally, general legal rules under Dutch law apply to this privacy statement.

12.What cookies do we use?

You can indicate which data we may use. If you have given us permission to personalize your profile based on your browsing and search behavior, we can tailor our website to your preferences to make its use easier and more personal. We do this using cookies. A cookie is a small text file placed on your device when you visit our website. We use non-anonymized analytical cookies to gain insights into website visits based on visitor numbers, popular pages, and trending topics. Specifically, we use the following cookie: Google Analytics (analytical cookie).
